

Knee pocket reinforcement fabric is woven fabric, 95% meta-aramid, 5% para-aramid, 2% antistatic, 220 g/m², colour Steel blue.

Contrasting panels are made of woven fabric, 54% MAC, 45% Lyocell, 1% antistatic, 300 g/m², in red colour.
